

# **Risk Assessment for Long Sutton Primary School to extend opening September 2020**

**Updated 17.07.20 for the full opening of school**

<p><b>Mental health and wellbeing pupils and staff</b></p>	<p>We are concerned about the impact of social distancing and lockdown on the mental wellness of our staff and pupils. The strain on families for homeworking and the death rates will have had an impact.</p> <p>We are mindful it is not all bad but wish to prepare appropriately. Some families will have enjoyed and thrived during this time together.</p> <p>We are concerned about the pressure on staff when we return The key concerns are:</p> <p>Lack of breaks, difficulty of meeting with other staff, cleaning, returning to a normal school routine.</p>	<p>Staff training on INSET days about dealing with trauma and anxious children</p> <p>Sharing of well being resources recommended by LA</p> <p>Therapeutic practices/ advice/ resources for pupils.</p> <p>Questionnaire to families about lockdown experiences. Information form this used to prepare for September.</p> <p>Individual interviews with children and staff in September about well being</p> <p>Increased time for reflection in classes and provision- mindful activities.</p> <p>Refocus of curriculum going forward on emotional and social development. Even more so than now. Focus on PSHE/ELSA type work, reading, play and having fun – re-bonding and re-establishing routines to start with.</p> <p>First week or two of term to focus on well being, settling back in and re-bonding.</p> <p>Open door policy of leaders continues.</p> <p>Not over enforcement of social distancing- common sense approach for working with young children.</p> <p>Absolutely no chastisement of pupils for failing to social distance- positive reinforcement aligned with our wellbeing and behaviour for learning and nurture based approaches.</p> <p>Staff to be encouraged to use ‘Care First’, also well being ideas to be send out.</p>

Year 1 work together for phonics, welly walk and forest school, the children will be kept at a suitable distance where possible or outside. Cygnet and Toy Box to be a bubble together (eating and playtime).</li> <li>• Classes will be kept separate where possible.</li> <li>• Classroom checks to be made with class teachers, caretaker and HT support before term starts</li> <li>• Individual resources packs prepared for pupils-this could include pencil, rubber, glue stick, scissors etc but also tricky word mats, phonics mats.</li> <li>• Staff to identify pupils who have been experiencing difficulties (Anxieties, learning challenges, bereavement etc) SENDCo to co-ordinate response. CTs and SENDCo</li> <li>• Social stories to be used to help prepare children for return. SENDCo. <b>Staff well-being</b>	<ul style="list-style-type: none"> <li>• Leadership to gain support from LA, CLP and school governors</li> <li>• Leadership to be accessible and supportive</li> <li>• Leadership to actively model, guide and remind staff of need to resources ‘self’ (rest, diet, family time etc)</li> <li>• Ensure pointers accessible E.g. for CareFirst HT (Telephone 01452 623200)</li> <li>• All staff to take care and time for each other</li> <li>• Share any worries with Leadership or colleague</li> <li>• Normalise people’s reactions- ‘It’s okay not to be okay’</li> <li>• Lizzie on site at all times to support day to day running and oversee</li> </ul>

	<ul style="list-style-type: none"> <li>• 1:1 meetings at a safe distance</li> <li>• Staff to maintain social distancing when taking breaks</li> <li>• Staff to receive full risk assessment and asked to input along with new working guidance</li> <li>• If staff are unwell to contact HT immediately via mobile, email and home phone, depending on time of day.</li> <li>• If staff are off sick, initially we will look to cover internally with part time staff or HT, if not we will look to external supply teachers, possibly via an agency or local know people.</li> </ul>
Beginning and end of the day	<ul style="list-style-type: none"> <li>• Head Teacher to supervise the gate and greet all children</li> <li>• Staggered start times to reduce numbers of people at gates: 8.45 Harrier, 8.50 Kite, 8.55 Kingfisher, 9.00 Cygnet, Toy Box see individual timetable</li> <li>• Staggered end of day times to reduced number of people at the gates: 3.15 Cygnet Class, 3.20 Kingfisher Class, 3.25 Kite Class, 3.30 Harrier Class</li> <li>• Parents choose 1 time for the whole family</li> <li>• Parents to ensure the school know if it is not them collecting their child, ring by midday – password needed if adult unknown to the school.</li> <li>• Parents to follow social distancing guidelines when arriving at school. Parents to leave once children are with school staff</li> <li>• Parents to follow the one way system and wait at 1m intervals marked</li> <li>• All messages via phone if possible or to the office or in writing.</li> <li>• All children and staff to wash/sanitise hands as they enter the building</li> <li>• Parents are asked to check their children are health before bringing to school and keep them at home if they have any concerns.</li> <li>• Families to walk or cycle if possible</li> <li>• 1 adult per family to come to school, unless this would be unsafe.</li> <li>• At the end of the day staff to bring the children out at allotted time, the children will then be called to come to the gate to meet parents</li> <li>• Messages for parents from the school to be phoned unless very brief.</li> </ul>

	<ul style="list-style-type: none"> <li>• Parents and children will be informed that they must not come to school if they have had any of the covid 19 symptoms within the past 14 days or until tested negative or have been in contact with someone who has got the symptoms or has tested positive</li> <li>• <b>It is essential staff keep to all these timings, as otherwise the system will fall apart. Give yourselves plenty of time (and then double it) for handwashing, lining up, explaining procedures etc. Be ahead of time!</b></li> </ul>					
Break Time	<ul style="list-style-type: none"> <li>• Playtimes to be taken when the classes chose in their own play area – toileting will need to be staggered and this may effect when playtime is.</li> <li>• Toilet times: Kingfisher 10.15, Kite 10.30, Harrier 10.45</li> <li>• Older children to be reminded about 1m distance</li> <li>• All games to be non-contact</li> <li>• All equipment used to be kept for specific group only and cleaned regularly</li> <li>• Any snacks given out to be handed to children and eaten in class. Gloves to be worn for this.</li> <li>• Children to wash hands before and after playtime.</li> <li>• Cygnets to use playground and playrun, Kingfisher to use the front play area, Kite class left end side of the field, Harrier class the right hand side of the field.</li> </ul>

Lessons/Classrooms	<ul style="list-style-type: none"> <li>• To be kept well ventilated at all times</li> <li>• Table spaced out and facing forward for all but Early years. Children not to be face to face.</li> <li>• Restrict movement about classroom where possible</li> <li>• Each child to have a zip lock bag with own stationery in with pens, pencil, ruler, scissors, glue, and other resources needed</li> <li>• Children should be supported to maintain distance and not touch staff and their peers where possible (Not possible with R/KS1)</li> <li>• Staff to approach children from the side where possible. Avoid close face to face contact and minimise time spent within 1 metre of anyone (Not possible with R/KS1)</li> <li>• Those pupils who have had low levels of engagement during lockdown and may require additional support will be seated nearer to the front or near support.</li> <li>• Each pupil will have their own set of resources in an individual tray under their desk space, to limit movement around the class. (Not Cygnets class and Toy Box)</li> <li>• No resources or toys to be brought in from home (Toy Box and Reception allowed comforter if needed)</li> <li>• Each child to have a named water bottle</li> <li>• Laptops and ipads to be sanitised after use</li> <li>• Shared resources to be sanitised or washed after use</li> <li>• If advise is needed from the office or photocopying needed, the phone must be used. Children should not be sent.</li> <li>• Regular handwashing to be built into the day.</li> <li>• If children move seats/tables – adults to sanitizer after use.</li> </ul>				



	<ul style="list-style-type: none"> <li>• Resources/games can be shared in class but will need to be with Milton regularly.</li> <li>• Children will have individual play dough pots</li> <li>• Water will have washing up liquid in it and be change regularly</li> <li>• Sand will not be used initially, but maybe used as confidence grows with Milton added to this.</li> <li>• Other sensory activities will be risk assessed before use and maybe carries out individually or in very small groups with hand sanitising increased.</li> <li>• Carpet areas: we will use markers or carpet tiles for ‘their spot’</li> <li>• PE equipment including gym equipment and mats will be sanitised between groups. Mats will be used by maximum of two children in a session (with only one child at a time on the mat)</li> <li>• If school closure occurs, ‘Home learning’ plans to resume. Home learning for children who are self-isolating to use whiterose, BBC Bitesize and Oak Academy lessons (Teachers not able to plan and teach 2 curricula)</li> <li>• Returned reading books to be placed in a box and wiped before returning to the system.</li> <li>• Children to gel hands before choosing a book and after.</li> </ul>
Pre-school/EYFS	<ul style="list-style-type: none"> <li>• Children will be allowed to play in their classroom as usual but children encouraged to keep their distance.</li> <li>• Children to have own bag of key resources (pens, crayons, pencils etc)</li> <li>• Children will enter via the main gate, parents not to come on site unless the separation is difficult. If so they can go to the outdoor area of Toy Box or Cygnet class, away from other adults.</li> <li>• Toy Box children will leave via the Front door to ensure a safe handover</li> <li>• EY children who need a comforter to choose one and to keep it in their bag for use if/when needed.</li> <li>• Resources will be limited each week due to the sheer number of small parts in the classroom. They will, where possible be wiped with antibacterial cleaning wipes/spray each Friday ready for the following week.</li> <li>• Intimate care such as first aid and toilet accidents will need to be managed carefully – staff will have access to aprons and gloves and sanitiser. Mask available if wanted / needed</li> <li>• Use the outdoor space as much as possible</li> </ul>

	<ul style="list-style-type: none"> <li>• Children will have individual play dough pots</li> <li>• Water will have washing up liquid in it and be change regularly</li> <li>• Sand will not be used initially, but maybe used as confidence grows with Milton added to this.</li> <li>• Other sensory activities will be risk assessed before use and maybe carries out individually or in very small groups with hand sanitising increased.</li> <li>• Carpet areas: we will use markers or carpet tiles</li> <li>• I pads used for Tapestry should be wiped down at the end of each</li> <li>• Resources that have been used and need wiping must be left in kitchen area/by the sink at end of day</li> <li>• Surfaces must be as clear as possible for effective cleaning</li> <li>• Toilets to be cleaned during children’s lunch time or after use by a member of staff</li> <li>• Clean tables before and after snack, lunch times</li> <li>• All bins should be double lined and emptied daily. Bins will be lidded.</li> <li>• Toys to be clean in Milton at the end of the day</li> </ul>
Cloakrooms	<ul style="list-style-type: none"> <li>• Use of these to be reduced as much as possible.</li> <li>• When used the numbers to be restricted and monitored by staff</li> </ul>
Hand washing	<ul style="list-style-type: none"> <li>• Reinforced upon entry and exit of the room and routinely through day</li> <li>• Gel or spray sanitiser in all classrooms</li> <li>• Extra mobile sinks to be in place for use at entrance to school</li> </ul>
Toilets	<ul style="list-style-type: none"> <li>• Limit numbers in toilet area, 1 class group at a time</li> <li>• Boys toilet 2 in cubicles and 2 at urinal at one time</li> <li>• Girls toilets, all cubicles can be used</li> <li>• Queue outside at 1m intervals using markings if full</li> <li>• Children can use at other times if needed</li> <li>• Increased cleaning – 11.30 and 2.00 - LH</li> <li>• Stagger use of these to ensure this.</li> <li>• Paper towels to be used not hand-driers</li> </ul>

<p>General</p>	<ul style="list-style-type: none"> <li>• Try to increase ventilation in classrooms by opening doors if possible, if it is too windy or wet for this, windows should be open. Everyone should dress appropriately for the cold.</li> <li>• All internal doors to be open so handles are not touched, where possible. If closed, handles sanitised regularly</li> <li>• If someone sneezes or coughs, they must wash their hands</li> <li>• The message: Catch it, Bin it, Kill it message, will be reinforced by staff and posters.</li> <li>• Children should be reminded positively about keeping their distance from others.</li> <li>• Children who have a temperature will be asked to stay off school or sent home if it rises during the day.</li> <li>• Any child or adult who has a temperature/fever (37.8 C) or a new continuous cough will be sent home, should go for a test and should self-isolate for 14 days (as well as any siblings). While they are waiting for collection they will wait in the medical room. For full symptoms see First Aid and illness section.</li> <li>• Children will need sessions focusing on their wellbeing and understanding the reasons behind our school changes so they do not become upset, too anxious or worried.</li> <li>• Posters around the school to encourage effective handwashing</li> <li>• Updated Fire risk assessment to be circulated to all staff – exit the building by the nearest door (trying to keep 1m apart, line up on field, staff to shut doors behind them and take fire register class line up on the field at a distance from each other</li> </ul>																												

Visitors to school	<ul style="list-style-type: none"><li>• No volunteer readers in school initially – further risk assessments needed for this.</li><li>• Any visitors to school must sanitizer hands and follow all school procedures</li><li>• Visitors to school must social distance from the children keeping at least 1m from them and 2m if possible</li><li>• Visitor who need to work 1 to 1 with children, parents should be made aware of this and approval given, working to be away from the other children.</li><li>• Reduced number of visitors or volunteers on site.</li><li>• No volunteers in classes at the start of the year but volunteers can be used for external working as long as they remain outside the building, keep their distance where possible. They will be expected to follow all procedures needed on entering the school site</li><li>• Where possible all contractors to do work after hours, but in an emergency, they may need to come in to the school. Social distancing will be adhered to and they will not be near to the children. School staff to accompany them.</li></ul>
Wrap around Care	<ul style="list-style-type: none"><li>• The school has decided it will run Breakfast and After school club for families who need this childcare.</li><li>• The children will break the bubbles for this.</li><li>• Where possible at 3.30 Club the children will be outside or will keep to 1m spacing</li><li>• At Breakfast Club the child will keep to 1m spacing, if more space is needed they will use the hall for this.</li><li>• If a child attending the clubs tests positive advise will be sort about self isolation of other pupils.</li><li>• The children will sanitizer their hands on entry, after eating and at regular intervals.</li><li>• Resources used will be carefully chosen, washed or isolated after use.</li><li>• Any ipads or laptops used to be sanitized after use</li><li>• Parents will not be allowed to enter the room for collection</li><li>• Staff will try to keep to 1m distancing from the children, where possible and ensure good hand hygiene</li><li>• Gloves to be worn for all food production</li></ul>

Intervention	<ul style="list-style-type: none"> <li>• Staff will wash their hands between groups. Pupils too will wash their hands before and after.</li> <li>• Pupils will bring all equipment they require with them to the intervention area/ Or TAs will prepared named packs</li> <li>• Where staff need to work with individual children or small groups of children from more than one bubble, care will be taken to maintain distancing.</li> </ul>
PE	<ul style="list-style-type: none"> <li>• Hall and outside areas may be used for PE but activities should ensure spaces between children are adhered to. The field should always be the preferred option when weather is dry.</li> <li>• Any equipment used would need to be cleaned afterwards- leave in hall for cleaning and then to returned to PE cupboard</li> <li>• Children to wash hands when they come back to 'class'.</li> <li>• Swimming to be delayed until Spring term</li> </ul>
Staff room and staff socialisation	<ul style="list-style-type: none"> <li>• Space out in here and keep numbers as low as possible – for larger gatherings e.g the end of the day, meet in the hall, Sunshine room or outside</li> <li>• Wash hands before handling equipment in here</li> <li>• Staff encouraged to bring own mug</li> <li>• All mugs to be washed in the dishwasher on a full cycle or using the commercial dishwasher.</li> </ul>
Office	<ul style="list-style-type: none"> <li>• All keyboards, desks, phones etc to be clean at the end of each day</li> <li>• No children to enter the office</li> <li>• Non-office staff should only enter if essential and 1 at a time after knocking</li> <li>• Office door to be locked to ensure people do not enter unless essential</li> <li>• Parents who need to speak to office staff should phone or email if possible.</li> <li>• Parents needing to speak in person should follow the one way system and wait at 2m intervals, as marked. The office staff will keep the hatch closed, or stand at a 2m distance from it.</li> </ul>
Wellness checks for staff prior to school	<ul style="list-style-type: none"> <li>• If staff have concerns about their health they should not enter school but seek advise first</li> </ul>
Uniform/ clothing	<ul style="list-style-type: none"> <li>• Children to wear school uniform</li> </ul>

	<ul style="list-style-type: none"> <li>• There is no requirement to wash this more often than normal but we would encourage regular washing</li> <li>• Named PE kit to be brought in at the start of term and kept in school until half term</li> <li>• All children to have wellies or outdoor shoes for playtime.</li> </ul>
Toys and resources	<ul style="list-style-type: none"> <li>• Reduce resources and toys easily available</li> <li>• Set of resources for a class, if possible</li> <li>• If resources are shared they need to be cleaned between use or isolated for 72 hours</li> <li>• Children to have tray on their table with pen, pencil, books, ruler etc, so little is shared.</li> <li>• Reduced soft toys/dressing up etc, these should be regularly washed</li> <li>• Don't use things that are hard to wash</li> <li>• No pencil cases or toys from home. Except EY children who need a comforter to choose one and to keep it in their bag for use if/when needed.</li> </ul>
Library books	<ul style="list-style-type: none"> <li>• Gel hands before choosing a book.</li> </ul>
Hall	<ul style="list-style-type: none"> <li>• Lunch use</li> <li>• Use for PE</li> <li>• Only 1 class at a time</li> </ul>
PE equipment	<ul style="list-style-type: none"> <li>• Only use hard items that can be washed</li> <li>• After use, keep away from children for 72 hours or wash.</li> <li>• Non- contact sports</li> <li>• Hands to be washed before and after PE lessons</li> </ul>
Children walking about school	<ul style="list-style-type: none"> <li>• Reduce this by no going to office/photocopier. Call office if they are needed.</li> <li>• Only use is: to go the library, move outside or toilet use.</li> <li>• Children to leave classes by external doors as much as possible.</li> </ul>
Drinks and packed lunch	<ul style="list-style-type: none"> <li>• All children to bring a named water bottle to keep on/under their table</li> <li>• Named plastic, washable lunch box only to be brought in</li> </ul>

Daily worship in class	<ul style="list-style-type: none"> <li>• All worship to be in class</li> <li>• ER to do teams whole school worship Monday at 9.05.</li> <li>• Possible church worship via teams</li> <li>• No singing</li> </ul>

First Aid and illness	<ul style="list-style-type: none"> <li>• If possible, to be dealt with by class adults or adult supervising at the time</li> <li>• If close contacted needed PPE to be used; gloves, aprons and masks (if wanted)</li> <li>• Normal school procedures to be followed e.g. banged head notes and monitoring, calling parents if concerned</li> <li>• If more support is needed phone to the office or Head for this.</li> <li>• There is a thermometer in the medical room to check temperature if there is a concern</li> <li>• First Aid bangs to be checked weekly and topped up.</li> <li>• If a child has suspected Coronavirus, they must be taken to the medical room and isolated, staff with them must wear PPE. Parents to be called immediately.</li> <li>• If a member of a child’s family has suspected corona virus, they should remain at home until the tests come back, if it is negative then they return to school, if positive they need to self isolate. If the child is in school, they should be taken to wait in the medical room for collection.</li> </ul>

	<ul style="list-style-type: none"> <li>• Medical room is available for isolation, Head or office will supervise this.</li> <li>• Parents will be informed that they must keep their children at home if they have any concerns about their health</li> <li>• Parents and staff informed that they must not enter the site if they show any symptoms of the corona virus. See below. They must isolate for 14 days or until tested negative. They must inform the school immediately.</li> </ul> <p>The most common symptoms are new:</p> <ul style="list-style-type: none"> <li>• continuous cough</li> <li>• fever/high temperature (37.8C or greater)</li> <li>• loss of, or change in, sense of smell or taste (anosmia)</li> </ul> <p>A new continuous cough is where you:</p> <ul style="list-style-type: none"> <li>• have a new cough that's lasted for an hour</li> <li>• have had 3 or more episodes of coughing in 24 hours</li> <li>• are coughing more than usual</li> </ul> <p>A high temperature is feeling hot to the touch on your chest or back (you don't need to measure your temperature). You may feel warm, cold or shivery.</p>
<b>Medication</b>	<ul style="list-style-type: none"> <li>• Children should keep inhalers in class as per medical plans</li> <li>• If a child needs other medication, parents must come to school to administer this.</li> </ul>
Safeguarding	<ul style="list-style-type: none"> <li>• Safeguarding is everyone's responsibility and the school's procedures continue to follow the school safeguarding policy, updated for covid-19 outbreak.</li> <li>• Any concerns must be recorded by staff as soon as possible on myconcern</li> <li>• The schools DSL/deputy must be informed of any concerns as soon as possible</li> <li>• Any child not in school to be called daily to check reasons why.</li> </ul>
Cleaning	<ul style="list-style-type: none"> <li>• All surfaces to be clean with anti virus cleaner or dilute bleach (this must be made up each day)</li> </ul>



- Mid-day cleaning of sink areas, tables, chairs, doors, handles etc, areas regularly touched.
- When cleaning hard surfaces use disposable clothes/paper towels
- Regular cleaning of toilet areas, 11.45 and 1.30
- Tables in the hall to be cleaned with antivirus spray before and after use
- Night time cleaning to ensure tables, chairs, doors and door surrounds are cleaned fully; floors to be hoovered or mopped; toilets fully cleaned – bowl – inside and outside, handle and cistern, floors, sinks and taps, doors. Bleach to be left in over night each day.
- All phones to be cleaned with anti-virus spray
- Staffroom – ensure dishwasher is set off for a full wash; sink and surfaces; water boiler
- Classroom resources used cleaned regularly
- Playrun to be wiped daily or hands sanitized before and after use (Toy Box/Cygnets staff responsible)
- Gym equipment to be wiped daily or hands sanitised before and after use (Kite staff responsible)
- I pads and laptops, surfaces wiped with anti virus spray or wipes.
- Front and back doors to be fully cleaned.
- All rubbish for classrooms to be double bagged at the end of the day.
- Classrooms to have pedal bins
- Wear disposable or washing-up gloves and aprons for cleaning. These should be double-bagged, then stored securely for 72 hours then thrown away in the regular rubbish after cleaning is finished.
- If an area has been heavily contaminated, such as with visible bodily fluids, from a person with coronavirus (COVID-19), use protection for the eyes, mouth and nose, as well as wearing gloves and an apron
- Wash hands regularly with soap and water for 20 seconds, and after removing gloves, aprons and other protection used while cleaning

Cleaning after a person with known or suspected corona virus has been in school

- Children may need to be removed to the school hall or outside while the area is cleaned if someone has suspected corona virus.
- Public areas where a symptomatic individual has passed through and spent minimal time, such as corridors, but which are not visibly contaminated with body fluids can be cleaned thoroughly as normal.
- All surfaces that the symptomatic person has come into contact with must be cleaned and disinfected, including:
  - objects which are visibly contaminated with body fluids
  - all potentially contaminated high-contact areas such as toilets, door handles, table and chairs
- Use disposable cloths or paper roll and disposable mop heads, to clean all hard surfaces, floors, chairs, door handles and sanitary fittings, with anti-virus cleaner/wipes or diluted bleach.
- Avoid creating splashes and spray when cleaning.
- Any cloths and mop heads used must be disposed of and should be put into waste bags as outlined below.
- When items cannot be cleaned using detergents or laundered, for example, upholstered furniture and mattresses, steam cleaning should be used.
- Any items that are heavily contaminated with body fluids and cannot be cleaned by washing should be disposed of.

**Waste:**

- Waste from possible cases and cleaning of areas where possible cases have been (including disposable cloths and tissues):
  - Should be put in a plastic rubbish bag and tied when full.
  - The plastic bag should then be placed in a second bin bag and tied.
  - It should be put in a suitable and secure place and marked for storage until the individual's test results are known.
- Waste should be stored safely and kept away from children. You should not put your waste in communal waste areas until negative test results are known or the waste has been stored for at least 72 hours.
  - if the individual tests negative, this can be put in with the normal waste
